## INCLUSIVE EDUCATION USING ANIMATION AND MULTIMEDIA VIDEO ANIMATION CONTEST

### TERMS OF PARTICIPATION

PLATFORMA-Urban Culture Co, a non-for-profit organisation with registered offices in Athens Greece (Kaisareias Street no. 6), with VAT No EL-999334608, (hereinafter for the sake of brevity the "Organizing Company"), is the rightsholder and organizer of Animasyros International Animation Festival and organizes the Video Animation Contest. The Video Animation Contest is organized, in the context of **the I\_AM project ("Inclusive education using Animation and Multimedia")**, a co-funded project by the Erasmus+ Programme of the European Union, which aims at the effective inclusion of children and young people with special educational needs and disabilities (SEND) in mainstream schools. The project is implemented by the following partners: CMT Prooptiki Ltd (GR), The Maria Grzegorzewska University (PL), IMEGEE (INSTITOUTO MELETON ke EREVNON GENIKIS ke EDIKIS EKPEDEFSIS) (GR) & Open University of Cyprus (CY) (collectively referred to as Project Partners) and the Organising Company.

### 1. THE VIDEO ANIMATION CONTEST

PLATFORMA-Urban Culture Co is holding a Video Animation Contest for the I\_AM project ("Inclusive education using Animation and Multimedia"). The Video Animation Contest is held to motivate the educational staff and the students to create a short animated video – **up to 3 minutes** – about inclusive education of children with SEND in mainstream schools. The competition is open to children and young people (age 9-14) from the 4 participating countries (Cyprus, Greece, Hungary, Poland). We welcome entries from schools, (collective works) as well as from individuals.

The competition is open to mainstream schools and in schools with children with SEND, as well as in mixed schools. The educational staff is expected to work along with the student in creating the Film.

The winning entries (one from each country) are going to be presented at the Animasyros International Animation Festival, which is organized by the Organising Company, on September 20-25, 2022 in Greece at the Island of Syros. The films will be presented during a special session dedicated to the inclusive education of children and young people with SEND, which will be organized for the purpose of promoting the rationale and results of the project. The winning videos will be also disseminated to other Animation Festivals across Europe and through the website and social media of the project. As a reward, representatives from the teams of each country will travel to Syros to present their teamwork at the festival.

Applications for participation in the competition are submitted **between 1 April 2022 (Greek time 00.00) and 30 June 2022 (Greek time 00.00)**. The procedure for participation in the Competition is as follows:

## 2. CANCELLATION OF PARTICIPATIONS

The Organizing Company has the right to verify the validity of the participations and to exclude any participant in the Contest or to prohibit its further participation, at its sole discretion, at any time, even without notice, as long as it deems that their participation is contrary to the provisions of the law or is done in bad faith.

Any participation is void, in particular, when it contains offensive content of honor and dignity of third persons, contains abusive, incendiary, racist content that offends human dignity or discriminates against individuals in the basis of national origin, religion or other beliefs, disability, age or sexual orientation, or is contrary to the relevant legal framework.

Furthermore, participation is void when it is not original and, therefore, constitutes the work of a third party and / or infringes the intellectual and/or industrial property rights of a third party.

## 3. PERSONAL DATA

The Organizing Company informs the participants that itself, and/or third parties, acting on its behalf and for it, will process the Personal Data, within the meaning of Regulation (EC) 2016/679 of the European Parliament and of the Council and of the Law No 4624/2019, which will be sent to it, for the sole purposes of implementing and promoting the Contest and its results (including activities such as promotion of the Contest, participation, awarding, announcement of results, promotion of the results), informing the Winners and awarding the prize. Participation in the Contest implies the unconditional consent of the participants (and any third parties) for the observance of their data and for their processing for the needs of conducting publicity of the Contest, as well as for the purposes of information and communication relating to it.

The participants in the Contest consent to any promotion of the Contest implemented by the Organizing Company and provide their consent for the use of their data, as they appear during the process of their participation in the Contest and from the publicly available data of their profile in Facebook for the above reasons, including the posting of the names and other details of the Winners on the Organizing Company Website as well the Websites of the participating partners of the I\_AM Project. The Participants in the Contest provide their explicit, unconditional and fully informed consent and authorization to the Organizing Company for the promotion of the Contest and / or its results through the printed and electronic press and / or the Internet. Thus, the Organizing Company reserve the right to use and publish for purposes related to the dissemination of the I\_AM project the list of Winners, photos, films and videos, and possibly use any news item related to this Contest, without, however, bearing any responsibility and / or obligation of a financial and / or promotional nature to the Winners.

Each participant has the right to access the personal data concerning them and may at any time request their modification or deletion from the respective file by letter to the Organizing Company. Also, the Organizing Company may request further information from the winners, when awarding the prize.

In the event that at any time a participant wishes to withdraw his consent to the use of his data in accordance with the above and to exercise the rights arising mainly from Regulation (EC) 2016/679 of the European Parliament and of the Council and the Law No 4624/2019 (rights of access, correction, restriction, objection, right to be forgotten, etc), can be contacted via email at [dpo@animasyros.gr](mailto:dpo@animasyros.gr)

The Personal Data of the Participants and Winners will be kept for a year after the announcement of the prize, according to the above, by the Organizing Company as responsible for their processing through automated or non-automated means, either by itself or through any other appointed person chosen, by order and on its behalf, for the purpose of the Contest, in accordance with the provisions of the above-mentioned legislation.



#### 4. INTELLECTUAL PROPERTY RIGHTS

The creators of the winning films, by submitting the application form automatically grant unrestricted license to use their final audiovisual work to the Organizing Company for any non-commercial or other related use without any territorial or time restrictions.

The Organizing Company, and all participating Partners of the I\_AM Project are entitled to share the videos of the participants through the share function in the accounts maintained by the Organizing Company on Social Media (Facebook, Instagram, etc.) for non-commercial, promotional and informational purposes, always in accordance with the terms of use of these Social Media.

#### 5. ACCEPTANCE OF THE TERMS OF THE CONTEST

The participation in the Contest entails knowledge and unconditional acceptance of the terms of participation as well as the consequent waiver of any relevant claim against the Organizing Company and the participating Partners of the I\_AM Project.
